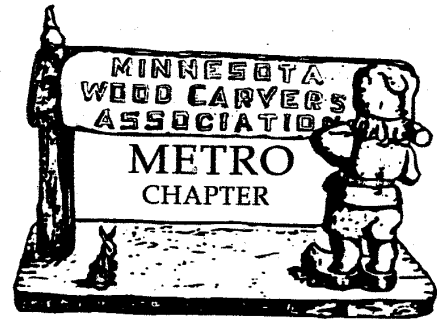

In this context, selling goods or services includes: taking orders, delivering goods to a buyer, quoting, displaying, or a later transaction, or any activity which could be construed as engaging in selling during this event.
